FyreWrap Blanket faced with 30 µm aluminium foil on one face.

#### **FyreWrap SF2 Blanket**

FyreWrap Blanket faced with 30 µm aluminium foil on both faces.

#### **FyreWrap SFR Blanket**

FyreWrap Blanket with 30 µm aluminium foil reinforced with 160 g/m<sup>2</sup> glass fibre mesh, on one face.

#### **FyreWrap SFR2 Blanket**

FyreWrap Blanket with 30 µm aluminium foil reinforced with 160 g/m<sup>2</sup> glass fibre mesh, on both faces.
