Conditions of Certification

1. When used in conjunction with an approved A Class steel deck.
2. 'A-60 Deck FyreWrap LT Blanket 64' A-60 Class deck consisting of 4.5mm thick steel deck insulated underside side with one layer of (45mm thick, density 64 kg/m³) 'FyreWrap LT Blanket' Alkaline Earth Silicate (AES) wool insulation manufactured by Unifrax Ltd, fitted to plate and around stiffeners. Total thickness of deck is 49.5mm.
3. Insulation retained to the steel deck and stiffeners with 3mm diameter steel pins and 38mm diameter steel washers: spaced at maximum centres of 300mm horizontally and 350mm vertically, a maximum of 350mm from insulation joints; a maximum of 135mm from edge boundaries running parallel to stiffeners; and a maximum of 150mm from the edge boundaries running perpendicular to stiffeners.
4. Maximum width of insulation blankets following installation: 600mm.
5. Insulation fixing method should be same as tested arrangement in all cases.
6. Composition, application and installation of subcomponents, including adhesives, seals and any fire retardants, to be maintained in production and use in accordance with originally tested composition formula and method of application and installation, and manufacturer's instructions.
7. Production items are to be manufactured in accordance with a quality control system which shall be maintained to ensure that items are of the same standard as the approved prototype.

The manufacturer shall keep a copy of the EC type-examination certificate, its annexes and additions together with the technical documentation at the disposal of the national authorities for at least 10 years after the wheel mark has been affixed on the last product manufactured and in no case for a period shorter than the expected life of the marine equipment concerned.
