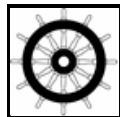

### Product description

"FyreWrap Marine Blanket (Insulfrax)" - A60 Steel Bulkhead (General) is composed of a structural steel bulkhead insulated with one layer of 55 mm "FyreWrap Marine Blanket (Insulfrax)" (manufactured by Unifrax with density 96 kg/m<sup>3</sup>) between the stiffeners. The stiffeners are insulated with one layer of 25 mm thick insulation of the same type as above.

The bulkhead insulation is fixed by steel pins and spring washers (approx. 22 set/m<sup>2</sup>).

For further details, see drawing listed under Type Examination documentation below.

### Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
