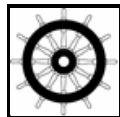

### Product description

"FyreWrap Marine Blanket (Insulfrax)" - A60 Steel Deck, is composed of a structural steel deck insulated underneath between and upon the stiffeners with one layer of 38 mm thick "FyreWrap Marine Blanket (Insulfrax)" (manufactured by Unifrax with density 96 kg/m<sup>3</sup>).

Anchoring of insulation to the deck is arranged with steel pins and washers (22 set/m<sup>2</sup>).

Total thickness is 43 mm.

For further details, see drawing listed under Type Examination documentation below.

### Application/Limitation

Approved for use as a horizontal fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation, use and maintenance.
