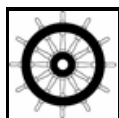

Product description

“FyreWrap Marine Blanket (Insulfrax)” - A60 Steel Bulkhead (Restricted), is composed of a structural steel bulkhead insulated with one layer of 38 mm thick “FyreWrap Marine Blanket (Insulfrax)” (manufactured by Unifrax with density 96 kg/m³) between and upon the stiffeners.

Anchoring of insulation to the bulkhead is arranged with steel pins and washers (22 set/m²).

Pins are to be installed with rectangular pattern and max. spacing of 320 mm between pins, max. 50 mm from the joints.

For further details, see drawing listed under Type Examination documentation below.

Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

Restricted application: fire from insulated side.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and use.
