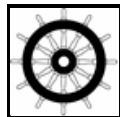

### Product description

"FyreWrap Marine Blanket (Insulfrax)" - A60 Steel Bulkhead (General), is composed of a structural steel bulkhead insulated of two layers "FyreWrap Marine Blanket (Insulfrax)" (manufactured by Unifrax with density 128 kg/m<sup>3</sup>). 25 mm thick bottom layer placed between stiffeners and 38 mm thick surface layer covered between and upon the stiffeners.

Anchoring of insulation to bulkhead is arranged with steel pins and washers (21 sets/m<sup>2</sup>).

Pins are to be installed with rectangular pattern and max. spacing of 320 mm between pins, max. 50 mm from the joints.

For further details, see drawing listed under Type Examination documentation below.

### Application/Limitation

Approved for use as a vertical fire retarding division of class A-60.

The insulation materials and adhesives used have to be approved according to the Marine Equipment Directive and bear the Mark of Conformity. This requirement may also be applicable for surface materials used, if required by relevant rules and regulations.

Each product is to be supplied with its manual for installation and use.
